THE HOME OPENED IN 2012 AND AIMS TO END GENERATIONAL POVERTY AND THE CYCLE OF CRISIS PREGNANCIES BY REBUILDING THE FAMILY BY PROVIDING A SUPPORT STRUCTURE, INSTALLING A SOUND VALUE SYSTEM, BUILDING LIFE-SKILLS AND PROVIDING EMPLOYMENT ASSISTANCE. HEALTHY START IS A COMPREHENSIVE PREPARATION FOR PARENTING WHICH EQUIPES PARTICIPANTS WITH PRENATAL AND CHILD CARE, BREAST FEEDING, AND ADOPTION EDUCATION.
