We fight to make sure that people who are accused of criminal offenses arent stripped of their rights just because they dont have enough money to defend themselves, and that people who are convicted of crmes dont leave the criminal justice system with so much debt that they are unable to successfully reenter society and support themselves and their families The following cases were in litigation in 2015 Valerie Gonzales et al vs City of Austin, Civil Action No 1 15-cv-00956-SS TFDP filed a class action lawsuit on behalf of Valerie Gonzales, Maria Salazar and all those similarly situated individuals at risk of being jailed by the City of Austin for inability to pay their fines and fees arising out of fine-only offenses before the Austin Municipal Court Plaintiffs alleged that the City of Austin has a policy and practice of jailing people unable to pay their fines and fees from traffic offenses and other Class C misdemeanors for as long as 45 days The case was pending at the end of 2015 In Re Ashley Willis, C1-CR-15-100048 This was a habeas petition filed on behalf of an indigent single mother, Ashley Willis, in the Travis County Court at Law Ms Willis had been committed to jail for over 20 days by the Austin Municipal Court because she could not pay fines and court costs stemming from class C tickets, in violation of federal and state law After filing the petition, TFDP secured Ms Willis's release by negotiating with the city prosecutors and a city judge Salinas v State, 464 S W 3d 363 (Tex Crim App 2015) TFDP wrote an amicus brief in this criminal case in the Texas Court of Criminal Appeals The defendant in the case alleged that the consolidated court cost, which is assessed in all criminal cases in Texas, was an unconstitutional tax because it does not go to fund the criminal court system The intermediate court found that he had failed to show that the statute was invalid, in part because he did not establish what the money from the consolidated court cost actually funds TFDP's brief tracked the money and found that much of the money went to fund government activities unrelated to the courts and in many cases unrelated to the criminal justice system as a whole Ex Parte Torres, PD 0679-14 TFDP, with co-counsel filed an amicus brief on behalf of Manuel Torres in the first Texas case addressing the standard for ineffective assistance of counsel post-Padilla where defense counsel failed to inform a non-citizen defendant that pleading guilty would almost certainly result in dire immigration consequences
