The Original Foundation developed divergent charitable objectives and desired to form two separate independent private foundations to carry out these respective objectives. The Original Foundation distributed one-half of its assets to the Bernard B. Rotko, M.D. Foundation, and such distribution was a transfer to a controlled foundation under Internal Revenue Code Regulation Section 1.507-3(a)(9). This plan has been presented to the Internal Revenue Service and the Bernard B. Rotko, M.D. Foundation has been granted tax-exempt status as a private foundation described in Section 501(c)(3) of the Internal Revenue Code.

As a successor to the Original Foundation, the Bernard B. Rotko, M.D. Foundation is not treated as a newly created organization pursuant to Internal Revenue Code Section 507(b)(2) and, instead, takes on the attributes of the Original Foundation in proportion to the value of the assets it received pursuant to Internal Revenue Code Regulation Section 1.507-3(a)(9). The Bernard B. Rotko, M.D. Foundation, therefore, shows one-half of the Original Foundation's excess qualifying distributions carryover and net value of noncharitable-use assets for years 2010 through 2014.
