The grant enabled WAPC to take the lead in the formation of the Wisconsin Perinatal Quality Collaborative and to continue upgrades and enhancements to PeriData Net. IN ADDITION, FUNDING OF \$54,696 WAS PROVIDED FOR STAFFING COSTS WHICH SUPPORT PERINATAL PROGRAMS. OF THIS AMOUNT, \$18,018 WAS ALLOCATED TO PROGRAM SERVICE EXPENSE
