Fresh Start-Emergency Shelter--The Fresh Start Emergency Shelter Program is designed to provide short term shelter and supportive services to 14 homeless single women, 13 homeless single men, and 10 homeless families at any point in time. By providing practical, applicable information, education and services in a condensed time-frame, individuals and families are provided intensive, "life ready" skills in the shortest period possible. During 2015, 596 people were provided shelter with supportive services, including 104 families with 200 children. 40% of participants who left Hope House obtained stable housing upon discharge.

4b (Code:) (Expenses \$ 495,583 including grants of \$ 14,312) (Revenue \$)

Safe Landing-Rapid ReHousing--New in 2015, we embraced the federal innovations in social policy and launched our Safe Landing Program. This program quickly moves homeless families from shelter or the streets into apartments of their own, case managers assist families in finding housing, and provide supportive services to the families while they're in their unit. In addition Hope House pays security deposit and up to 1 year's rent assistance. In 2015, Safe Landing served 63 families, including 134 children. At the end of the operating year, 94% of the families remained in their unit or exited to permanent housing, and 74% of families had maintained or increased their total income. Families were placed into housing in an average of 26 days from program entry, to housing move in, making it a truly rapid exit from homelessness.

Mercy Housing--In partnership with Mercy Housing Lakefront, Hope House provides supportive services to the housing units Mercy Housing Lakefront owns and manages. At the Johnston Center Residence, Hope House provides supportive services in the 91 unit building with 41 units set aside for those that are Chronically Homeless, and 50 units for individuals with a history of homelessness. At the St. Catherine's Residence for Women, Hope House provides supportive services to 25 disabled, homeless women, 6 mothers with infants and others in the building needing extra assistance.

Part III Line 2 - In 2015, Hope House received a HUD CoC grant which allowed it to start the Safe Landing Rapid Re-housing for Families

Program. This program allows families to move directly from homelessness to apartments of their choosing in the Community. Hope House provides rent assistance and intensive supportive services to the families while they are in their unit for up to one year.

Part II Line 3 - In 2015, Hope House, following national research and best practice trends ceased running the Chrysalis Transitional Housing program for families and converted the HUD CoC grant funding to the Safe Landing Rapid Re-housing for Families. Internal Program space was converted to the Fresh Start Emergency Shelter.

In 2015, Hope House also outsourced operation of the United Southside Food Pantry to Friedan's Community Ministries. Friedan's is very highly regarded in our community as a provider of food pantry services and was looking for a space in our area to run a pantry. As such, we turned operation and ownership of the program over to them and they rent out the pantry space from us.

Protective Payee Services for disabled adults and families (Expenses \$2,448 including Grant of \$) (Revenue \$)

The Protective Payee Program is designed to provide financial oversight, budget counseling and supportive case management for individual with severe mental illness and other disabilities who need that little extra support to prevent homelessness. The program provides careful financial oversight for individuals with limited disability income, so that the individual stays in housing and has the resources to provide for basic needs.
