4a (Code) (Expenses \$ 813,326 including grants of \$ 0) (Revenue \$ 994,829)
 Our services to adults with disabilities include day services, community integration, work/prevocational services, sensory integration, and transportation. These services focus on life skills training, recreation and leisure time activities, social skills, using technology, self advocacy and self-direction, and community. Life skills training include cooking, personal hygiene and appearance, and healthy lifestyle activities. Community inclusion services are comprised of supporting individuals to learn more about community activities such as museums, parks, and other community places. Individuals are also supported in giving back to their communities through volunteer activities. The Summer Student Program, provides training through social modeling and experience based learning, decision making skills, self direction, accessing technology, and interpersonal communication. Our sensory integration component adapts Montessori concepts to teaching adaptive behaviors to persons with sensory input disorders. Our work/prevocational services are designed to give individuals an opportunity to earn a paycheck while developing the necessary skills and work habits to obtain competitive employment. Work options in the work/prevocational program include industrial subcontracts, assembly, packaging, manufacturing and distribution of products, mailing services, confidential document shredding, janitorial, ground maintenance and rest area maintenance. Our transportation program operates six routes and transports 100 individuals who reside in Forest, Oneida, and Vilas Counties to Headwaters throughout the week. We receive funding from the Wisconsin Department of Transportation for accessible vehicles through the Section 5310 Elderly and Disabled Transportation Capital Assistance Program, which covers 80% of the cost of the vehicles purchased through this program. Since 2002 we have been awarded 34 specialized vehicles valued at over \$2.5 million.

4b (Code) (Expenses \$ 182,570 including grants of \$ 0) (Revenue \$ 233,748)
 Community employment training and job placement programs are designed to provide persons with the opportunity to work in regular jobs for community employers at minimum wage or higher. These services assist individuals in acquiring the necessary job skills to be hired by an employer and maintain the job. Components of the program include vocational assessment, developing an individualized employment plan, job development, training and job coaching, and follow along support when necessary. Individuals are also counseled on soft skills such as interpersonal communication. In 2015 the Community Employment Program served 122 individuals, 108 of whom were referred by the State of Wisconsin Division of Vocational Rehabilitation.

4c (Code) (Expenses \$ 222,065 including grants of \$ 0) (Revenue \$ 270,247)
 Enterprise activities offer people served a job and a paycheck while working on skills to gain employment in the community. Activities include packaging and sewing for one of the largest pet supply companies in the world-Petco, and sorting and packaging feathers for Trueflight Manufacturing. We also provided maintenance at several boat landings in the area for the Department of Natural Resources, and we maintained green space near dams along the Wisconsin River for Wisconsin Valley Improvement. In addition, we also have an annual contract to do spring cleanup for our local hospital. Our confidential shredding business provided steady work for participants throughout the year.
