The Eau Claire Community Foundation offers ways to make it easier for community members to give to local charities by contributing to existing funds at the Foundation, establishing their own funds, and facilitating pass-through gifts In 2015, we provided 199 grants to fulfill needs throughout the community, including \$1,700 to the Chippewa Valley Theatre Guild for new theatre chairs, \$2,000 to the Children's Dyslexia Center for Hands On Experience Dyslexia Stations, \$2,000 to the Boys and Girls Club for Health and Nutrition Programming, and \$9,000 to Feed My People Bank for its Food Outreach Program In 2015, the M & J Employee Impact Fund was created to help Market & Johnson employees become actively engaged in philanthropy by contributing fo the Fund and helping recommend its grant recipients We provide educational support and consultation to area non-profit organizations regarding planned giving and endowment building To raise awareness for the importance of members of the community to be philanthropic we sponsor a yearly educational event with the Women?s Giving Circle, and distribute information about philanthropy through our website and newsletters We also host forums to promote philanthropy and provide information to our donors, and provide technical assistance for non-profit organizations and grantees in their fund-raising activities We track grantees' progress to ensure we are making wise funding decisions, and assist them in developing their grant-writing skills
