WISDOM Leaders published the Blueprint for Ending Mass Incarceration in 2015, with specific, fully achievable plans to keep people from entering prison and help people stay out of prison, as well as to release nearly 3000 people who are eligible for it right now At the end of 2015, WISDOM re-branded its campaign "ROC Wisconsin Restoring Our Communities " It will continue to promote the issues lifted up in the Blueprint Four major work groups were established state-wide to educate and mobilize the public around these initiatives, and a new organization of formerly-incarcerated people was launched WISDOM held Poverty Symposiums in Milwaukee, Stevens Point, Appleton, Eau Claire and Madison to encourage people to consider the relationships between faith, public policy and poverty in their electoral decisions We circulated a Faithful Citizenship Statement, signed by hundreds of faith leaders WISDOM provided leadership training workshops in each of the 12 affiliate organizations, sent more than 40 leaders to Gamaliel's week-long National Training Institute, provided four 2-day training workshops for leaders and had training components during the annual Board Retreat and at 3 board meetings











