Section 1. The TCA Volunteers' Coffee shop shall hereinafter be known as the Coffee Shop.

Section 2. The fiscal year of the Coffee Shop shall begin January 1 and shall end December 31.

Section 3. The position of Coffee Shop Coordinator shall be an employee of ThedaCare, whose compensation is reimbursed by the TCA Volunteers, and supervised under the direction of the ThedaCare Organization's Volunteer Services Manager.

Section 4. The Coffee Shop Coordinator shall have fiscal reporting for the Coffee Shop and shall:

- A. Utilize a bookkeeper, who shall be an employee of ThedaCare, whose compensation is reimbursed by the TCA Volunteers, and supervised under the direction of the Gift Shop's Assistant Store Manager and the ThedaCare Organization's Volunteer Services Manager.
- B. Be surety bonded, along with the bookkeeper, in an amount recommended and paid for by the ThedaCare Organization.
- C. Ensure the bookkeeper handles all payables and receivables in an appropriate and timely fashion and provides reports of Coffee Shop financials (income, expenses, balance sheet, profit and loss statements) on a monthly basis to the TCA Volunteers Board of Directors.
- D. Work with the bookkeeper and TCA Volunteers Board of Directors to have the Coffee Shop accounts reviewed annually and the results submitted to the TCA Volunteers Board of Directors.
- E. Present financial goals to the TCA Volunteers Board of Directors and the Volunteer Services Manager at the beginning of the fiscal year.
- F. Select and purchase all merchandise for the Coffee Shop. Capital expenditures require approval from the TCA Volunteers Board of Directors.
- G. Manage the Coffee Shop inventory on an on-going basis, facilitate an annual physical inventory and submit results to the TCA Volunteers Board of Directors.
- H. Communicate events, sales, buying trip outcomes, etc. to the Volunteer Services Manager and the TCA Volunteers Board of Directors at Board meetings.
- I. Notify the TCA Volunteers Board of Directors and the Volunteer Services Manager in advance of any buying trips and submit a travel expenditure report upon return.

- J. Ensure that all Coffee Shop records are placed in the area designated by the TCA Board of Directors following the fiscal year.
- K. Work with the board president to establish a committee of volunteers, upon recommendation by the Volunteers Board of Directors, to help generate ideas, goals and direction for the Coffee Shop. This committee shall include at least one member of the TCA Volunteers Board of Directors.
- L. Work with the Volunteers Board of Directors' Treasurer to establish primary and secondary signatories for all Coffee Shop accounts.

Section 5. Gifting to ThedaCare Regional Medical Center-Appleton:

- A. By February 15th of each year, the Coffee Shop Coordinator, with advice from the bookkeeper, shall submit a proposal to the TCA Volunteers Board of Directors with the amount they propose for gifting purposes, along with financial documentation to support the proposed amount.
- B. The TCA Volunteers Board will review the proposal and approve the final gifting amount.

ARTICLE X. THE VOLUNTEERS' GIFT SHOP

Section 1. The TCA Volunteers' Gift Shop shall hereinafter be known as the Gift Shop.

Section 2. The fiscal year of the Gift Shop shall begin January 1 and shall end December 31.

Shall work with the TCA Volunteers Board of Directors to hire a Gift Shop Assistant to work with the Assistant Store Manager to prepare merchandise for sale and help train and assist gift shop volunteers. The Gift Shop Assistant shall be an employee of ThedaCare, with compensation reimbursed by the TCA Volunteers, and supervised under the direction of the Gift Shop's Assistant Store Manager and the ThedaCare Organization's Volunteer Services Manager.
- G. Select and purchase all merchandise for the Gift Shop. Capital expenditures require approval from the TCA Volunteers Board of Directors
- H. Manage the Gift Shop inventory on an on-going basis, facilitate an annual physical inventory and submit results to the TCA Volunteers Board of Directors.
- I. Communicate events, sales, buying trip outcomes, etc. to the Volunteer Services Manager and the TCA Volunteers Board of Directors at Board meetings.
- J. Notify the TCA Volunteers Board of Directors and the Volunteer Services Manager in advance of any buying trips and submit a travel expenditure report upon return.
- K. Ensure that all Gift Shop records are placed in the area designated by the TCA Board of Directors following the fiscal year.
- L. Work with the board president, to establish a committee of volunteers, upon recommendation of the Volunteers Board of Directors, to help generate ideas, goals and direction for the Gift Shop. This committee shall include at least one member of the TCA Volunteers Board of Directors.
- M. Work with the Volunteers Board of Directors' Treasurer to establish primary and secondary signatories for all Gift Shop accounts.

Section 5. Gifting to ThedaCare Regional Medical Center-Appleton:

- A. By February 15th of each year, the Assistant Store Manager for the Gift Shop , with advice from the bookkeeper, shall submit a proposal to the TCA Volunteers Board with the amount they propose for gifting purposes, along with financial documentation to support the proposed amount.
- B. The TCA Volunteers Board will review the proposal and approve the final gifting amount.

ARTICLE XI. DISSOLUTION

Section 1. In the event of dissolution of TCA Volunteers, provisions shall be made for settlement of all liabilities of the organization.
