Rules for prequalifying potential gifts:

1. Grants under \$200 require written request from an established organization.
2. Grants of \$200-\$500 require a written request along with a listing of the Board of Directors, a copy of an annual budget and expenses and a reasonable definition of the mission of the organization.
3. Grants of \$500 - \$1,000, in addition to the above, require examination of the percentage of funds used for promotion, as opposed to the actual services from the mission of the organization. Anything less than 10% will be considered reasonable, 10-20% will be considered questionable, and more than 20%, for all practical reasons, will disallow support.
4. Grants of \$1,000 or more, in addition to the above, will require a copy of the long-range plans and goals for several years of the organization. Milestones need to be identified and accomplished. A copy of an annual unqualified audit should also be submitted.
