The union through employees, members and specialists negotiated approximately 150 contracts covering 13,500 members. The objective of these contract negotiations are to provide members with improved working conditions, job protections, better benefits and higher wages. The union through employees, members and specialists resolved 300+ grievances of which 27 were referred to the Council Arbitration Screening panel for approval. 18 of these grievances were approved for arbitration. The objective of pursuing these grievances includes protecting workers jobs, improving the working conditions of members, and to ensure the contract terms are enforced. The union through employees and member volunteers ran 17 separate organizing campaigns. Some of these campaigns are to increase member density to improve bargaining strength and expanding union membership into new employers and organizations to improve working conditions of people not yet covered by union contract. Other programs include: 1) Member training in contract enforcement, organizing and community outreach. 2) Conferences and convention to ensure member involvement in governance, setting the mission of the union, and increasing member involvement.
