Prevention and Education Public education and the implementation of prevention-based programming are important elements to the overall mission of the Rape and Abuse Crisis Center. Trainings and presentations are available to places of employment or community groups on issues of healthy relationships, domestic violence, sexual assault, sexual harassment, child abuse, or other issues of interpersonal violence. In the area of prevention-based education, numerous presentations and programs are presented to local schools regularly. Programming includes "Red Flag Green Flag" personal safety curriculum, "I Wish the Hitting Would Stop" domestic violence prevention curriculum, and for older students, programming related to healthy relationships and dating violence is available. In 2015, The Rape and Abuse Crisis Center provided 911 presentations reaching 19,620 individuals, 766 presentations reached 16,423 elementary, middle, high school and college students, 131 presentations reached 2,799 community members, and 14 presentations were provided to 398 professionals (law enforcement, nurses, social workers, etc.). Engaging the community in working to prevent domestic and sexual violence is an important part of RACC's work. In 2015, RACC hosted a "Mask You Live In" event with two public film showings focusing on the pressures placed on boys and men in society, followed by panel discussions that further explored the issues presented in the film. Pre- and post-tests were also conducted at the events to measure changes in perception before and after viewing the film Sexual Assault Services. The Rape and Abuse Crisis Center (RACC) provides crisis intervention, advocacy and counseling to victims of sexual assault and child sexual abuse. Crisis intervention includes staff and volunteers responding to the immediate needs of victims. In 2015, RACC served 977 victims of sexual assault, 280 of those victims were children. RACC is a member of the community sexual assault response team (SART). Advocacy services may include assistance to victims during hospital exams, law enforcement investigations, and with obtaining orders for protection. Ongoing counseling services are provided to primary and secondary victims. Advocates provided service to victims of sexual assault at Emergency Centers on 93 occasions in 2015 Domestic Violence Services. The Rape and Abuse Crisis Center provides crisis intervention, advocacy and counseling to victims of domestic violence. In 2015, RACC provided services to 1,804 victims of domestic violence including 113 children. Crisis intervention includes staff and volunteers responding to the immediate needs of victims following an incident of violence. Advocacy services may include assistance to victims during hospital exams, law enforcement investigations, and with obtaining Orders for Protection. In 2015, RACC assisted 88 victims in obtaining emergency Orders for Protection. Counseling services are provided to primary and secondary victims following the initial crisis. RACC also works with local law enforcement officials to reach out to victims identified in domestic violence incident reports, in 2015, staff reviewed 1,828 reports and made contact with 1,183 victims. Victims were provided with information on the criminal justice system, their rights and services available to them. RACC provides emergency financial assistance to victims who need help with food, rent, utilities, transportation, medication, and other necessities. Advocates responded to victims of domestic violence in Emergency Centers on 17 occasions in 2015 CAC Family Advocate Services. RACC provides a Family Advocate at the Red River Children's Advocacy Center. The Family Advocate provides assessment, education, emotional support, and information and referral services to non-offending caretakers of children who are undergoing an interview as part of a sexual abuse investigation. Many of the children identified in RACC's sexual assault services are seen at the RACC initially. In 2015, there were an additional 98 caretakers and 95 children who were seen by RACC's Family Advocate but who were not viewed as a sexual abuse victim after the investigation. Services to children who are Sexually Acting Out (SAO). In 2015, 13 children and 14 parents were served where children were inappropriately sexually acting out and parents were requesting, and received, education and counseling.
