	In 2015 the Community Foundation awarded \$1,573,105 in grants and \$324,783 in scholarships. Total grants awarded (including interfund grants) comprised of 20% unrestricted funds, 9% designated, 16% field of interest, 11% organizational endowments, 34% scholarships and 10% donor advised. The largest program area supported was human services with 25% of grant funds, followed by 18% in education, 6% in arts, 7% in environment, 7% community and economic development, 3% other, and 34% scholarship. In 2015 the Community Foundation awarded \$210,283 scholarships from endowed funds and \$114,500 from 10 temporary scholarship funds that the Foundation provides scholarship services. In addition the Foundation provided administrative services for two affiliated scholarships totaling \$620,000 where all of the funds are held by a local bank DSACF contracted with a software vendor to create new software for an online application process for scholarships, grants and e-committee data for DSACF committees. In 2015 the online application process for grants, scholarships and e-committee data for DSACF committees was completed and training sessions were provided by DSACF Program Staff.
