Distributed \$165,500 to various Benevolent Funds, Food Shelf's and other organizations, such as the Thanksgiving and Christmas meal hand-outs operated by the local Lion's Club and Salvations Army. Per responses received from the organizations funds were distributed to provide thousands of meals and other basic living expenses for individuals and families in the area.

Total disbursements was \$272,915 including \$165,500 distributed to other organizations who help families and individuals. True operating expenses were \$107,415.
