Our small business advocacy efforts were unable to secure additional funding but the DEED business competitive grant program was held steady at \$2.8 million for the biennium and a good foundation was built for future efforts. Additionally, a small \$180 million bonding bill passed this session, including \$10 million in bonds for housing. Coalition for Choice in Housing. MCCC continued to lend our support to the Coalition for Choice in Housing's work to eliminate the 25% cap in Minn. Stat. 256B.492, which currently limits individuals with disabilities to residing in no more than 25% of the units. The bill passed with the cap eliminated in the final Health and Human Services Omnibus bill, SF 1458. Economic Development. MCCC worked to increase the funding available for our small business members and clients and proposed policy changes to the Urban Initiative Program (UIP) that would have made those dollars easier to use throughout the Twin Cities Metro. This work was supported by seven of our member organizations who also do economic development work. These changes were introduced in SF1154/HF1105. Both the Senate and House bills were supported by a bipartisan group of lawmakers who represent the communities in the Twin Cities Metro area that would benefit from an expanded UIP program. The bills received three hearings, and were well received. Funding and policy changes were included in the House omnibus appropriations bill, HF 1437, and increased funding but no policy changes were included in the Senate omnibus appropriations bill, SF 2101. Unfortunately, the omnibus bill that these provisions were a part of was part of late-night and contentious negotiations that resulted in most policy provisions, and much of spending increases being removed from the final bill. Then that bill was vetoed by Governor Dayton due to unresolved contentious issues. The House and Senate reconvened on June 12th for a one-day special session that passed an omnibus bill that included funding for the DEED business competitive grant program at \$2.8 million for the biennium (HF 3) but did not include any of our policy changes or funding increases. It is our intention to continue discussions with our members, partner organizations and local government partners so we can collaboratively pursue additional funding for small businesses throughout the Twin Cities Metro area. Minneapolis Public Policy After a number of years in which the Minneapolis Affordable Housing Trust Fund (AHTF) failed to receive adequate funding, Downtown Congregations to End Homelessness (DCEH) and MCCC brought together Minneapolis-based affordable housing advocates and allies to organize a campaign around the 2014 Minneapolis budget. These efforts led to the creation of the 'Make Homes Happen' coalition. In July 2015, the coalition organized a campaign to increase budgetary resources for affordable housing at the local level. These advocacy efforts helped win full funding for the AHTF at \$10 million (a \$1.5 million increase over the mayor's proposed budget). At the same time, the campaign was able to raise awareness about the need for a strategic plan to deal with the city's vacant properties in residential districts.
