28 Transitional Housing Summary Freedom Place provided long term transitional housing to forty-seven individuals in 2015, including 12 females and 35 males. Of those, nine individuals were terminated for not maintaining sobriety, seven were terminated for lease violations, six moved without giving proper notice, seven moved into permanent housing without serious issues. The remaining 18 resident held over into 2016 at Freedom Place. This year we added a new property at 717 Orange in February 2015. We are now providing housing at five homes in the city of Saint Paul. Jobs and Training Summary Freedom Place hired and trained eleven clients to work as door to door canvassers who brought in \$60,226 to help fund our program. They earned collectively \$29,292 in payroll. Additional four clients were trained to serve as house managers to make sure our homes stay clean and sober. Each manager was given a rent discount in exchange for their duties. Also several residents volunteered to run our organic vegetable garden that provides fresh and healthy food for themselves and other residents. We also used several residents to help remodel the new property we purchased at 717 Orange Ave by adding a basement bedroom with an egress window. Other maintenance and repair tasks at the other homes were performed by residents to keep the properties up to code.
