Supportive Services Title III-B The MAAA funds five (5) supportive service areas that consist of chore and homemaker (including grocery shopping and delivery assistance), information and assistance, legal, special access services for minority elders, and transportation Each organization that is a recipient of Title III-B funds provides services focusing on individuals who are low-income, socially isolated, with particular attention to low-income minorities and those with limited English proficiency to help them remain in their communities In 2015, the MAAA and our supportive services provider partners served 2,258 persons with 32,354 hours of chore and/or homemaker services, 583 persons with 12,546 grocery deliveries, served 73,953 consumers via the Senior LinkAge Line(R), provided 2,794 persons with 7,752 hours of legal and counseling and assistance, 1,817 persons with 15,550 hours of one-to-one special access services or group assistance, and 1,138 persons with 52,818 one-way assisted transportation trips

Information and Assistance (Long-term care consultation, housing with services consultation, prescription drug assistance, return to community and health insurance counseling In 2015 MAAA assisted 73,953 older adults, family caregivers and service professionals through our Senior Linkage Line(R) to evaluate needs, connect to services, learn about housing options and get answers to medicare, insurance and prescription drug payment questions The agency's community living specialists met with 1,906 private-pay nursing home residents and provided 298 of those individuals with in-depth assessment and care coordination MAAA staff processed approximately 34,988 screenings through Pre-Admissions Screening The screenings are intended to identify individuals whose needs might be better met in the community and connecting them to home and community-based services In 2015, 95 volunteers contributed 8,946 hours to program activities assisting in many service areas, including the Medicare Phone Bank, face-to-face health insurance counseling, education and outreach
