HOSPICE In 2015, North Memorial Hospice served 1,000 patients. For patients experiencing financial hardships, Foundation dollars paid for utilities, medical costs, equipment, and other expenses. The Foundation also paid for costs associated with hospice patients receiving Massage and Music Therapy services.

4b (Code) (Expenses \$ 112,293 including grants of \$ 74,350) (Revenue \$)
Pay It Forward Fund. This fund was established by a breast cancer survivor and her husband in October of 2005. In February of 2006, the first Pay It Forward fundraising event was held and over the last nine years more than \$1.2M has been paid toward patient bills of cancer patients and their families. During 2015, the fund provided patient assistance in the amount of \$151,991 with a maximum per patient of \$1,500. Patients eligible for assistance are from North Memorial, Maple Grove, Mercy, Unity, Monticello, Ridgeview, and Hennepin County Medical Center. The fund is administered at no fee through the foundation. Each year the fund helps nearly 200 patients buy groceries, pay their mortgages, heat their homes, pay for utilities, repair their cars, and assist with unfunded medical bills. The fund helps patients to pay expenses so they can focus on what's really important-getting healthy. THE PAY IT FORWARD FUND WAS TRANSFERRED TO ANOTHER, UNRELATED HOSPITAL FOUNDATION IN JUNE OF 2015.

4c (Code) (Expenses \$ 111,559 including grants of \$ 86,611) (Revenue \$)
SafeJourney Program. In response to community need, an emergency awareness of the crucial role health care providers can play in assisting abuse victims, North Memorial Medical Center developed a comprehensive response to proactively identify and respond to patients at North Memorial and Maple Grove Hospital who are suffering from family violence. Founded in 1994, SafeJourney provides a variety of direct services, advocacy, assessment, intervention, prevention and education to assist over fourteen hundred individual victims of abuse as well as the larger community each year. Services focused on the northern and western Twin Cities suburbs and Minneapolis' north side, include 24 hours/day, seven days/week coverage of the hospital, using skilled volunteers to provide patient assessment and advocacy, two weekly support groups for battered women, and community and professional education. In 2015, over \$100,000 in foundation funds was used to support over 100 volunteers serving more than 1500 domestic abuse encounters.
