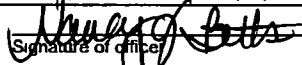

The Organization provides services to "Persons Living With or affected by HIV/AIDS" (PLWHA). In 2015, the Organization served 322 PLWHA. Of those served 57 were new to the Organization. Partner clinics and infectious disease specialist provided primary medical care to 219 PLWHA and made 413 visits. Staff and partner agencies conducted 875 rapid HIV tests and provided prevention counseling. Case Managers served 278 clients. More than 58 PLWHA attended meetings with the Organization and support group activities. In addition to this medical transportation was provided to 178 clients and over 7,500 individuals in the community received educational and outreach information.
