THE MISSION OF JEREMIAH PROGRAM IS TO TRANSFORM FAMILIES FROM POVERTY TO PROSPERITY TWO GENERATIONS AT A TIME SINCE 1998, JEREMIAH PROGRAM HAS SERVED LOW-INCOME SINGLE MOTHERS AND THEIR CHILDREN THROUGH A PROVEN, HOLISTIC APPROACH BASED ON FOUR KEY PILLARS SUPPORT FOR A CAREER TRACK COLLEGE EDUCATION, QUALITY EARLY CHILDHOOD EDUCATION, SAFE AND AFFORDABLE HOUSING, AND EMPOWERMENT AND LIFE SKILLS TRAINING THROUGH THIS APPROACH, JEREMIAH PROGRAM PREPARES DETERMINED SINGLE MOTHERS TO EXCEL IN THE WORKFORCE, READIES THEIR CHILDREN TO SUCCEED IN SCHOOL, AND REDUCES GENERATIONAL DEPENDENCE ON PUBLIC ASSISTANCE AN INVESTMENT IN THESE FAMILIES AT THIS CRITICAL TIME IN THEIR LIVES PROVIDES A MEANINGFUL RETURN ON INVESTMENT A RECENT STUDY BY WILDER RESEARCH SHOWED THAT A \$1 INVESTMENT IN THESE FAMILIES CAN RETURN UP TO \$4 TO SOCIETY THROUGH DECREASED DEPENDENCE UPON PUBLIC ASSISTANCE, INCREASED TAXABLE EARNINGS, AND REDUCED COSTS ASSOCIATED WITH CRIME AND SPECIAL EDUCATION
