

ARTICLES OF INCORPORATION  
OF  
BOYS AND GIRLS CLUB OF DULUTH FOUNDATION

We, the undersigned, for the purpose of forming a corporation under and pursuant to the provisions of Chapter 317A of Minnesota Statutes, known as the Minnesota Nonprofit Corporation Act, do hereby associate ourselves together as a body corporate and adopt the following Articles of Incorporation.

ARTICLE I.

Name of Corporation

The name of this corporation shall be:

Boys and Girls Club of Duluth Foundation *et al*

ARTICLE II.

Purpose of Corporation

The corporation is formed to establish the Boys and Girls Club of Duluth Foundation (hereinafter referred to as "Foundation"), shall be operated in connection with the Boys' Club of Duluth, Inc. (d/b/a Boys and Girls Club of Duluth) and exclusively for charitable and educational purposes, all as contemplated and permitted by Sections 170(c)(2) and 501(c)(3) of the Internal Revenue Code of 1986, and in particular:

To support, maintain, assist and for the benefit of the Boys' Club of Duluth, Inc. its operations, programs, grounds, structure and facility.

This Foundation is created and shall be operated to accept (subject to the reasonable discretion of the Directors), hold, invest, reinvest, administer and disburse any gifts, bequests, devises, benefits of trusts, and property, personal or real, tangible or intangible, of any nature, without limitation as to value, and from any source, and to disburse the income and principal as set forth herein.

However, no gift, bequest or devise of any such property shall be received and accepted if it is conditioned or limited in such a manner as to require the disposition of the income or its principal to any person or organization other than a "charitable organization" or for other than "charitable purposes" organized and operated exclusively for such purposes or as shall, in the opinion of the Directors, jeopardize the federal

income tax exemption of this Foundation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986.

For such purposes, and not otherwise, the Foundation shall have and exercise only such powers as are required by and are granted by law and consistent with the foregoing purposes. All such powers of the Foundation shall be exercised only so that the activities of the Foundation shall be exclusively within the contemplation of Sections 170(c)(2) and 501(c)(3) of the Internal Revenue Code of 1986, and of Section 290.05 of the Minnesota Statutes, and as the same are amended from time to time. The reference herein to Section 290.05 of the Minnesota Statutes shall not permit, and shall not be taken as permitting, the Foundation to have or exercise any power which is not within the contemplation of Sections 170(c)(2) and 501(c)(3) of the Internal Revenue Code of 1986. The Foundation shall not carry on any activity not permitted to be carried on by an organization that is exempt from federal income taxes under Section 501(a) of the Internal Revenue Code of 1986 or by an organization that is described in, and contributions to which are deductible for federal income tax purposes under, Section 107(c)(2) of the Internal Revenue Code of 1986.

The Foundation shall annually distribute at least 85% of the net income of the Foundation to or for the benefit of the Boys and Girls Club of Duluth, for general operating expenses. The Foundation may distribute all or any part of the remaining annual net income to or for the benefit of the Boys and Girls Club of Duluth. Any income not so distributed shall be accumulated and added to principal. The Foundation may distribute from time to time all or a portion of such accumulated net income solely for capital improvements, major structural repairs, or expansion of the Boys and Girls Club of Duluth.

Notwithstanding the foregoing, this corporation shall distribute for each of its taxable years, amounts at least sufficient to avoid liability for the tax imposed by Section 4942(a) of the Internal Revenue Code of 1986. For purposes of these Articles of Incorporation, the term "income" means, for each taxable year of this corporation, the distributable amount with respect to this corporation as defined in Section 4942(d) of the Internal Revenue Code of 1986. Net income shall not include gifts made to the Foundation or the proceeds from the sale or disposition of donated or investment property unless so defined by said §4942(d).

This corporation may not engage in an act of "self-dealing" (as defined in Section 4941(d) of the Internal Revenue Code of 1986) that would give rise to liability for the tax imposed by Section 4941(a) of the Internal Revenue Code of 1986.

This corporation shall not retain "excess business holdings" (as defined in Section 4943(c) of the Internal Revenue Code of 1986) that would give rise to liability for the tax imposed by Section 4943(a) of the Internal Revenue Code of 1986.

This corporation may not make any investments that would jeopardize the carrying out of the exempt purposes of this corporation, within the meaning of Section 4944 of the Internal Revenue Code of 1986, so as to give rise to liability for the tax imposed by Section 4944(a) of the Internal Revenue Code of 1986.

This corporation may not make a "taxable expenditure" (as defined in Section 4945(d) of the Internal Revenue Code of 1986) that would give rise to liability for the tax imposed by Section 4945(a) of the Internal Revenue Code of 1986.

Except as permitted by Minnesota Statutes, Section 317A.501, this corporation shall not lend any of its assets to any officer or director of this corporation or guarantee to any other person the repayment of a loan made to an officer or director of this corporation.

All reference in this Article II to a particular section of the Internal Revenue Code of 1986 shall mean and include, as now enacted or as hereafter amended, such section or any provision of federal law as is or may hereafter be applicable, cognate to such section; and the reference to Section 290.05 of the Minnesota Statutes shall mean and include as now enacted or as hereafter amended, or may hereafter be applicable cognate to such provision.

### ARTICLE III.

#### Corporation Duration

The duration of this corporation shall be perpetual.

The Foundation shall not, incidentally or otherwise, afford or pay any pecuniary gain, dividends, or other pecuniary remuneration to Directors, officers or members of the

Foundation as such, and no part of the net income or net earnings of the Foundation shall, directly or indirectly, be distributable to or otherwise inure to the benefit of any Director, officer or member of the Foundation or any other individual. A director or officer may be reimbursed from Foundation funds for vouchered authorized expenditures incurred in the performance of his or her duties. No part of the activities of the Foundation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Foundation shall not participate in or intervene in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office.

## ARTICLE VI.

### Directors

The number of directors constituting the Board of Directors of this corporation shall not be less than seven (7) or more than fifteen (15). The term of office of the Class One Directors above named shall expire at the first annual meeting; the term of the Class Two Directors shall expire at the third annual meeting; the term of the Class Three Directors shall expire at the fifth annual meeting. Upon expiration of the terms of office of the Directors as classified above, their successor shall be elected for the term of five (5) years each. No Director may serve more than two (2) consecutive five (5) year terms. At least one (1) Director from each class of Directors shall also be a Director of the Boys' Club of Duluth, Inc., and which Directors shall also serve on the Foundation's Investment Committee.

In case of a vacancy on the Board of Directors other than a vacancy occurring because of the expiration of a term in office, the vacancy may be filled by election at any special meeting of the Board of Directors called for that purpose, or at any meeting of the Board of Directors by a majority vote of the remaining directors; provided, however, that the appointee shall serve only for the balance of the vacated term.

A quorum for meetings of the Directors shall be one-half of all the Directors then serving.

Any action required or permitted to be taken by the Board of Directors or any committee thereof may be taken without a meeting if all members of the Board of Directors or the committee consent in writing to the adoption of a resolution authorizing the action. The resolution and the written consents thereto by the members of the Board or committee shall be filed with the minutes of the proceedings of the Board or committee.

## ARTICLE VII.

### Personal Liability

No member, director or officer of the corporation shall be personally liable to any extent whatsoever for obligations or liabilities of the corporation.

## ARTICLE VIII.

### Capital Stock

The corporation shall have no capital stock.

## ARTICLE IX.

### Officers

The Board of Directors shall elect the persons to exercise the functions of the offices of President, Secretary and Treasurer, who shall be natural persons of full age. The terms of office shall be for one (1) year and until their successors are elected and qualified. Officers need not be members.

## ARTICLE X.

### Committee

The day-to-day management and direction of the business and affairs of the Foundation shall be vested in a governing body to be known as the "Foundation Executive Committee", (hereinafter referred to as the "Committee"), subject always to the directions and control of the Board of Directors of the Foundation. The members of the Foundation Executive Committee shall be such persons as shall from time to time be appointed by, and each of whom shall serve at the pleasure of the Board of Directors of the Foundation. The number, qualifications, term or terms of office, method of election, powers, authority, and duties of the Committee and such other reasonable rules and procedures with respect to them as are not inconsistent with the express provisions of

these Articles shall be as are from time to time determined by the Board of Directors. The Committee shall meet at such times and places and on such notice as the Committee shall from time to time determine.

## ARTICLE XI.

### Members

Membership in the corporation, shall consist of the Directors of the corporation serving from time to time. Members will have voting rights only as Directors.

## ARTICLE XII.

### By-Laws

Authority to make and/or alter the By-Laws of this corporation is vested in the Board of Directors, subject to the provisions that they are consistent with the Articles of Incorporation and the laws of the State of Minnesota.

## ARTICLE XIII.

### Distribution Upon Dissolution

Upon dissolution of the Boys and Girls Club of Duluth Foundation, all assets and properties of the Foundation shall be distributed to the Boys' Club of Duluth, Inc., or its respective successor institution to be used for charitable and educational purposes, and only if the Boys' Club of Duluth, Inc., or its successor, is an organization described in Sections 170(c)(2) and 501(c)(3) of the Internal Revenue Code of 1986, but if not, then as determined by a court of competent jurisdiction. Notwithstanding anything apparently or expressly to the contrary contained in this Article, if any assets or properties are then held by the Foundation in trust or upon condition or subject to any executory or special limitation and if the condition or limitation occurs by reason of the dissolution of the Foundation, such assets shall revert or be returned, transferred or conveyed in accordance with the terms and provisions of such trust, condition or limitation.

## ARTICLE XIV.

### Amendments

These Articles of Incorporation may be amended from time to time in the manner provided by law.




