Filed a lawsuit against the state for barring trans people on medical assistance from receiving the health care they need. Established the Gender and Sexuality (GSA) Network and are working with over 70 schools across the state. Worked with youth to organize the Youth Summit and the Catholic Youth Summit attended by nearly 600 youth. Trained over 500 people on being advocates for trans justice. Filed complaints with the Equal Employment Opportunity Commission against employers who have health plans that exclude coverage for transition services. Engaged faith communities. Partnered with Black Lives Matter Minneapolis on LGBTQ Lobby Day to advocate for trans health care and voting rights. Opened a youth library with over 400 LGBTQ books, all donated. Engaged over 300 volunteers and interns in our work.
