Civil rights, democratic development, emergency aid, and advocacy programs Los Olivos CIS organizes Community Network for Cooperation and Solidanty made up of 29 community organizations Workshops were organized in the Network about Water Rights, Social Construction of Gender and Violence against Women, Food Sovereignty, Recycling, and Violence Prevention Los Olivos CIS plays a role in the campaigns for water rights, food security and sovereignty, and against damaging metallic mining It also supports educational campaigns of SIGESAL, the public hospital workers association for medical reform and workers' rights CIS provided accompaniment for several communities, assisting with community benefit projects such as land legalization, electricity, computer workshops, community kitchens, latrines, and solar energy CIS organized its 11th International Election Observer Mission hosted and trained 75 international observers for the 2015 Legislative and Municipal Elections in March There were 9 long term volunteers trained by CIS in international election observation and worked from 3 to 6 months to help coordinate the mission CLEAN WATER is currently a major focus of CIS community assistance efforts 303 Sawyer water filters were distributed to 12 communities in 2015 and a total of 1,631 filters to 32 communities since we began the program in 2011 The CIS clean water campaign not only distributes filters and teaches families how to use and maintain them We also do two day training on the environment, health, hygiene and correct use of filters prior to the distribution Through an agreement with Clean Water for the World CW4W, we installed six industrial water purification systems, primarily in educational centers Clinics and Educational Centers as well as water committees Los Olivos CIS has formed in the communities have reported a vast reduction in waterborne illnesses, and results of better school attendance and grades since students are not missing classes as often due to related illnesses Over 8,000 people benefited from the purifiers Additionally, the Communities of La Loma an Cuyanigua inaugurated a potable water solar energy project developed by ACUA and the communities with Los Olivos CIS providing the purchase of land for the project In May 2015, the Romero Community was granted land titles after a 10 year struggle accompanied by the CIS By November, we were able to get building permits and broke ground on the construction of 65 dignified homes for families who had spent 10 years living in shacks made of tin and plastic Los Olivos CIS in cooperation with Living Waters drilled a well for the community to have access to potable water Los Olivos CIS worked for a donation of 5,400 soccer balls from One World Play Project CIS organized the distribution of the balls in 28 municipalities in 8 of El Salvador's 14 departments, and organized a tournament with 6 female and 5 male soccer teams, as part of CIS work for violence prevention

Youth Formation and Scholarship Programs Provides education to potential community leaders who would not be able to study without help and at the same time build their awareness of their role as agents for making changes for social justice The CIS worked with 16 local Salvadoran committees and organizations and 17 sister organizations as well as individual donors to raise funds for 135 youth to go to the university and 204 to go to high school in 2015 The program focused on strengthening community organization and networking to prevent violence as a response to increased student dropout rates due to violence and the threat of violence Monthly leadership, formation and analysis sessions were organized for students and their parents by CIS community organizers Formation and training in the national reality, food sovereignty, roots of violence, violence prevention, election reforms, HIV AIDS prevention, gender equality, self- esteem, human rights, climate change, environment, and other themes were carried out with scholarship committees and recipients Scholarship students carried out volunteer programs including community cleanups, clean water campaign follow-up, tutoring grade school students in reading and writing, coordinating a health campaign with a clinic, adult literacy classes, and more The CIS organized a 3 day retreat and leadership development training for 100 scholarship recipients in La Palma, Chalatenango which focused on an analysis of violence, making a risk map of each separate community and making a plan for violence prevention CIS School for Solidanty and Social Transformation facilitated a leadership training program for 6 months with 30 community representatives focused on gender equality

International cultural exchange and education Educational delegations and language and cultural exchange 23 international volunteers taught English classes to 200 local community members during 4 nine week sessions The volunteers received orientation about El Salvador and the empowerment work of Los Olivos CIS CIS continues coordinating with the University of El Salvador to provide Salvadoran students majoring in English with training and an opportunity to practice their profession and fulfill their 500 hours of social work requirement by teaching at the CIS 110 international participants received Spanish instruction and cultural orientation from local native speakers CIS hosted 18 delegations with a total of 200 participants in 2015 Delegates visit El Salvador to gain an in depth understanding of the social and economic reality of El Salvador The delegation program also promotes solidarity with communities and grassroots organizations working for social and economic justice Los Olivos CIS hosted a delegation to investigate the situation of women who are imprisoned for miscarriages and obstetric emergencies, falsely accused of having an abortion and spending 30 - 40 years in prison for their alleged crime We organized an exchange with business administration students from Marquette University who worked with women from the Local Food Basket Store in San Pablo Tacachico to develop a basic business plan
