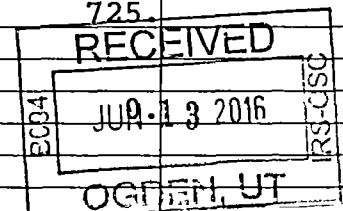

**ARTICLES OF AMENDMENT
AMENDING AND RESTATING THE
ARTICLES OF INCORPORATION
OF
THE CADAHEMARK FOUNDATION**

The Cadahemark Foundation, a Minnesota nonprofit corporation (the "Foundation"), acting through its President, hereby files these Articles of Amendment amending and restating its Articles of Incorporation as follows:

ARTICLE I.

Name

The name of the Foundation is The Cadahemark Foundation.

ARTICLE II.

Purposes and Activities

The Foundation is organized and shall be operated exclusively for charitable, scientific, and educational purposes within the meaning of Sections 501(c)(3), 170(c)(2), 2055(a) and 2522(a) of the Internal Revenue Code of 1986, as amended ("the Code"). Within the limitations established by the preceding sentence, the Foundation is organized and shall be operated primarily to help expand understanding and increase awareness and enjoyment of culture and language through support of education of young people, to make grants and contributions to organizations which are exempt from federal income taxation under Section 501(a) of the Code by virtue of being described in Section 501(c)(3) of the Code, and do any and all other acts and things and exercise any and all other rights and powers which may be reasonably necessary, incidental, desirable or expedient in the accomplishment of such purposes.
