Exhibition Program. Over the past year, we originated 5 world premiere exhibitions from a diverse group of artists based in Berlin, Barcelona, Minneapolis, Los Angeles, and Tokyo. These exhibitions presented the work of 5 artists. All the work was commissioned by Midway through our continued artist stipend program. These exhibitions received very positive reviews and coverage in local, national, and international press outlets both trade industry and general public. Public Educational Programs. In addition to exhibitions, our other programmatic efforts have been increasingly strong. We presented performances by artists such as Simone Forte and Jenna Bliss, lectures from Guerino Mazzola, Roc Jimenez de Cisneros, Curtis Roads, James Hoff, and conversations with philosophers Isabelle Stengers and Vinciane Despret. We continue to host book launches and reading groups for local area artists and publishers. We continue to provide many tours for area college and university classes. Library. Our research library has continued to grow in its collection and its reach. We have added 1,000 volumes to the collection, which now stands at 6,500 volumes. We are currently working on a major redesign and relaunch of our website with a particular focus on the library's presence. This will be launched in 2015.
