Youth Activities. During 2015, the Foundation provided funding for educational, environmental and recreational programs for the youth of Saint Paul, MN and the surrounding communities. Many of the youth served by this programming are underprivileged or identified as at-risk. The Organization held four youth events, including the following: Les Farrington Best 100 Junied Art Exhibition, Punt Pass and Kick, Pitch Hit and Run, and Minnesota Miss Amazing. The events involved approximately 75-100 volunteers and positively affected more than 1,000 youth in the Saint Paul Area.

Community Involvement. During 2015, the Foundation provided funding for educational and recreational programming for the citizens of Saint Paul and the surrounding communities. The events were largely targeted at underprivileged populations. In total seven events were sponsored, including Amy Johnson Residence, Feed My Starving Children, Citywide Spring Cleanup, Special Olympics Holiday Party, Dorothy Day Center Toiletry Packing, Ronald McDonald House Cooks for Kids, and Meals on Heels (Meals on Wheels). The events involved approximately 100-150 volunteers and directly affected 800-1000 people as well as hundreds of Special Olympians, families staying at Ronald McDonald House, patrons of Dorothy Day Center, Feed My Starving Children beneficiaries, and more in the Saint Paul area indirectly.
