PUBLIC RELATIONS: Promoted & hosted two Stroke Detection Plus screenings for members and community with 52 participants. Hosted an annual meeting for all members to display and promote member benefits and activities of the organization. Organization leaders were introduced and recognized with 91 attended at a cost of \$1,398. Sponsored a local cookout contest at County Fair, promoting quality Iowa meat. Several hundred fair attendees stopped during the cookout contest, at a total cost of \$656. Promoted Natl Ag Day with advertising, news releases and Farm Bureau leaders visiting with the public at a local grocery store. Shoppers were presented with ag related trivia and coupons given away for their food purchases. 2 shopping sprees were given out to promote agriculture, build trust and project a positive image to the community while celebrating National Ag Day for a cost of \$481. The Company participated in a local parade

EDUCATION: The Company strongly supports agricultural education and has worked very hard at keeping local schools and students aware of how important agriculture is. The ways they have accomplished this is with an active Ag In The Classroom committee communicating to teachers, educators and schools promoting resources and grant opportunities available to incorporate agriculture into the classrooms. The Company also provided scholarships to high school seniors for college tuition totalling \$2,000. Participated with the 3rd Grade Ag Education Day for area schools 300 third grade students in Benton County gathered at the county fairgrounds for a day of educational tours and informational booths. Participated in a Farm Safety Day Camp for 4th, 5th and 6th grade students in the area. Volunteers educated attendees about the hazards around the farm and promoted safety. Sponsored young farmers to attend the Iowa Farm Bureau Federation Young Farmer Conference & informational meetings. 10 members had the opportunity to participate in estate and farm succession education and planning

POLICY DEVELOPMENT: Members met several times with elected state and national officials to discuss the importance to agriculture. Met with county board of supervisors and county officials discussing budgets affecting the company's members. Committee formulated a survey for members. This was made available to all members and encouraged them to participate in the grassroots policy development process. Policy was written based on results of the survey for the ag communities. Worked together with other ag groups in promoting nutrient reduction, water quality and conservation practices to help prevent possible regulation in the future and take a proactive approach by educating & helping producers implement practices specific to their operation. Company helped with field days & provided various signage. Issue surfacing meetings were held where members were encouraged to surface, post and prioritize rural and ag related issues through
