To retain long-term talent in the financial services industry, in addition to offering a 401K Salary Savings Plan, Dupaco provides designated executives with a non-qualified long-term executive incentive plan. Designed to be self-funding in nature through the achievement of growth and member service initiatives, the funding cost of supplemental Retirement Plan benefits will be recouped by the credit union through life insurance policy proceeds on plan participants. A tool for retention, the participating staff member must remain at the credit union until retirement age to become fully vested in the deferred compensation benefit.
