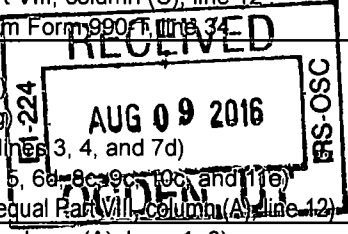

The Company's board and members then support local and state policy by contacting the representatives and lawmakers. The Company board members attend meetings held at the capital to support Farm Bureau policy. The Company meets National representatives to discuss national issues at a regional board meeting.

AG EDUCATION The Company is a strong supporter of agricultural education. The Company has worked very hard at keeping agricultural education in the local schools. The Company sponsors an AG4Kids Day for 5th graders at local elementary schools. Local & State Commodity groups are invited to the classroom and the fairgrounds to explain the different ways agriculture is a part of our everyday lives. The Company awarded 4 scholarships that totalled \$2500. The Company continues to work with the local FFA Chapters and 4-H Clubs to promote agriculture in the community. The Company sponsors a AG Mystery Walk at the county fair to help promote ag to local youth.

The Company sponsored a photo contest promoting Agriculture in Pictures for 5 different classes with a wide variety of ages from kids to adults during the County Fair. The Company also holds a winter theme coloring contest with the Winterset Elementary grades Pre-K thru 3rd Grade. The Company gives donations to local schools for their After Prom parties to help promote safe proms. The Company buys trophies for the County Fair from local commodity groups. The Company donated Plat Books to the Winterset Firefighters Association. Donations were also given to the local food pantry, 4-H Clubs that clean trash along the Farm Bureau Adopt-A-Highway area, the local fairgrounds to help improve the driveway and the SWCD.
