An opinionnaire is sent out to members each year regarding topics dealing with local, state and national issues. Proposed resolutions are then formulated and presented at a board meeting and thoroughly debated and amended as needed. Adopted resolutions are then supported by the Voting Delegate at the State Policy Conference. The Company's Board and members support local and state policy by contacting State Representatives and lawmakers. The Company hosts Legislative forum meetings every month to stay in touch with lawmakers and issues important to their 3,315 members. The Company also sends representatives to attend meetings held at the State Capital to support Farm Bureau policies and ag related issues. The Company meets National representatives to discuss national issues at a regional board meeting.

AG EDUCATION The Company is a strong supporter of agricultural education. The Company has worked very hard at keeping agricultural education in the local schools. The Company provides teachers from local schools with agricultural information and classroom materials to be presented in their classrooms. The Company also awarded 6 college scholarships that totaled \$3,000 during the year. The Company continues to work with the local FFA Chapters to develop an Agriculture Day for the urban elementary students. The Company sponsors a scavenger hunt at the County Fair to promote Agriculture to local youth. Provided an IPAD for Ag in the Classroom programs.
