



The Company's Board of Directors met with County Supervisors, County Engineer and Auditor to review/scrutinize the 2015-2016 budget and also lobby for additional funding for rural roads/bridges. The Board President attended the American Farm Bureau annual meeting to lobby for the best interests for national agricultural policy. A board member traveled to Washington DC to lobby state congressman for congressional issues related to agriculture. The Company donated \$2000 towards the agriculture legal defense fund that is being used to help defend three counties in Iowa in litigation from Des Moines Water Works over nitrate levels found in the Raccoon River watershed.
4b	(Code _____) (Expenses \$ <u>3,271</u> including grants of \$ _____) (Revenue \$ _____) EDUCATION/AG IN THE CLASSROOM The Company helped sponsor a four county-wide 5th Grade Youth Environmental Days at the Wright County Fairgrounds in Eagle Grove. Approximately 800 students attended one of the four day event where they learned about by-products that come from corn/soybeans, farm-to-market, farmers feeding the world along with other agricultural related sessions. The Company also provided a series of agriculture breakout sessions to all of the students at 2 local school districts (500+ students). The sessions were taught by three Ag In The Classroom teachers over a three day period of time. The Company also donated funds to the Webster County 4-H Foundation and provided 2 - \$500 college scholarships to two graduating Farm Bureau member high school seniors and 1 - \$1000 scholarship to an Iowa Central Community College Ag Student.
4c	(Code _____) (Expenses \$ <u>13,944</u> including grants of \$ _____) (Revenue \$ _____) AGRICULTURAL PROMOTION The Company donated \$1,500 to the Almost Home Pet Shelter where all animals that are adopted are injected with a microchip should the pet ever be lost or stolen. The Company co-sponsored a two day Farm News Ag Show held in Fort Dodge that was attended by over 2,000 local farmers at a cost of \$1,000. The Company was also the corporate sponsor of the Dayton Rodeo that was attended by over 3,000 over the three day event at a cost of \$1,000. The Company ran a series of radio ads (\$2,430) and newspaper ads (\$3,250) during the summer months to educate the general public about conservation practices used by farmers to preserve the soil & keep our waters clean. The Company promoted Ag Week in March by conducting a \$300 shopping spree. While the shopping spree in taking place board members are on the radio informing the listening audience (5,000+) about the significant role agriculture play in their daily lives at a cost of \$1,267. \$3,497 was donated to area food banks to help feed over 1000 adults/children.
