THIS AREA OF SERVICE ALSO INCLUDES EXTENDED SHELTERED EMPLOYMENT, MEDICAID WAIVER PROGRAMS, AND FIVE SESSIONS OF WEEK-LONG SUMMER CAMP WHERE 345 CAMPER, BETWEEN THE AGES OF EIGHT AND TWELVE, WORKED ON SOCIAL DEVELOPMENT SKILLS WHILE ENJOYING OUTDOOR ACTIVITIES AND EXPOSURE TO NATURE. INTENSIVE SERVICES WERE PROVIDED TO 673 INDIVIDUALS IN 2015. THESE SERVICES ENCOMPASS EDUCATIONAL AND CAREER SERVICES WITH A CASE MANAGER OR DIRECT SERVICE WORKER ASSIGNED TO EACH PARTICIPANT WITH SERVICES DELIVERED OVER AN EXTENDED PERIOD OF TIME. MAINTENANCE AND ENHANCEMENT OF SKILLS OR INDEPENDENT FUNCTIONING LEVEL, OR MAINTENANCE OF EMPLOYMENT IS THE EXPECTED RESULT OF PROGRAMS AND SERVICES IN THIS CATEGORY. PLACEMENT FOCUSED SERVICES WERE PROVIDED TO 1,423 INDIVIDUALS IN 2015. THESE SERVICES HAVE AN EXPECTED OUTCOME OF JOB PLACEMENT THROUGH JOB DEVELOPMENT AND DIRECT JOB PLACEMENT PROGRAMS, AS WELL AS TEMPORARY PLACEMENT SERVICES AND PRE-PLACEMENT PHASES OF SUPPORTED EMPLOYMENT SERVICES. A CASE MANAGER OR DIRECT SERVICE WORKER IS ASSIGNED TO EACH INDIVIDUAL PARTICIPATING IN PLACEMENT FOCUSED PROGRAMS AND SERVICES.
