A directory is printed each year with members names and contact information which is distributed to members and beef buyers. Approximately 6,000 directories are published. A newspaper is printed six times a year with information on the angus breed of cattle and member information about the association such as minutes of the last meeting and upcoming association events. These are distributed to members and buyers with approximately 4,500 copies printed. Members also attend trade shows and fairs to promote the angus breed of cattle.
