**Part III, Line 2 - New Program Services**

In 2015, United Way of Mahaska County began two new initiatives. Oskaloosa Summer Lunch Program is a USDA funded summer food service program which provides free nutritious meal to children in the Oskaloosa Community School District. The Take-Along Food Program is a United Way of Mahaska County initiative which provides a weekend bag of shelf stable food to school-identified children in need of food assistance.

In addition to these programs, United Way of Mahaska County resumed participation with the Iowa Reading Corps to provide funding for sponsorship of two Americorps volunteers at Oskaloosa Elementary School to work with students that were identified by the school as needing assistance with meeting reading proficiency guidelines established by the state.

**Part III, Line 4d - Other Program Services**

Designated Gifts: Expenses - \$27,378 (including grants of \$27,378) - United Way of Mahaska County accepts designated donations from donors during the annual fundraising campaign. Donations are forwarded to designated human service 501(c)3 agencies.

Special Grants: Expenses - \$21,000 (including grants of \$21,000) - United Way of Mahaska County provided Special Grants to 5 local agencies in Mahaska County. Programs funded included helping pay for basic needs, housing assistance, programming supplies, and building and equipment repairs.

Live United 5K & Healthy Kids Day: Expenses - \$4,262 - Each spring gives us warmer weather and an opportunity to get outside to exercise and have fun with our families after a long winter. Together with Mahaska County YMCA, we offer an event that highlights our local agencies and other agencies promoting healthy living. Through participating in this event, agencies are able to inform the public of the wonderful services they provide to Mahaska County residents. Community members can participate in our 5K Run/Walk and then celebrate with family and friends. We tailor the day towards families, as we know the importance of building strong family relationships. Prizes are given away and fun is had by all.

Volunteer Center: Expenses - \$3,666 - United Way of Mahaska County operates a Volunteer Center in Mahaska County. Local agencies are able to post volunteer needs on the Volunteer Center website. Community members can access the website to find volunteer opportunities that match their interests and availability. The Volunteer Center coordinated many volunteers for the Oskaloosa Summer Lunch program in 2015.

**Take-Along Food Program:** Expenses - \$3,186 - United Way of Mahaska County was approached by volunteers that were interested in providing weekend food assistance to children at the Oskaloosa Elementary School that were food insecure. Working with the school, United Way developed a discrete process for providing food to school-identified children whose parents agreed to having their child bring home a bag of nutritious, shelf-stable food for the weekend.

**Operation Backpack/Stuff the Bus:** Expenses - \$1,834 - Each summer, United Way of Mahaska County sponsors Stuff the Bus, a school supply drive to gather supplies for Operation Backpack. Operation Backpack provides school supplies to Mahaska County children in low income families. Any child or youth (preschool through 12th grade) residing in Mahaska County is eligible for the program. In 2015, we supplied over 400 backpacks to families in need. Leftover school supplies were given to local schools to stock school supply closets, which can be utilized by teachers throughout the school year. We partnered with SIEDA, Salvation Army and the school districts in Mahaska County.

**Day of Caring:** Expenses - \$1,347 - United Way of Mahaska County empowers volunteers in our community to come together to assist in completing projects for those in our community that might not otherwise be completed. We organize volunteers to work on a variety of projects each year, including those that serve seniors and individuals with disabilities, city and county projects, local non-profit agencies and schools. In 2015 we completed 13 projects with approximately 90 volunteers.

**Winter Coat Drive:** Expenses - \$1,308 - United Way of Mahaska County coordinated promotion for the local Coat Drive, in partnership with New Hope Community Center. We also provided manpower for distribution of collection boxes and regularly collected coats and other winter outerwear items and delivered them to New Hope, where they were available to the public for free.

**VITA Tax Site:** Expenses - \$502 - United Way of Mahaska County recruits volunteer, coordinates and hosts a VITA Tax Preparation Assistance Site. IRS Certified Volunteer Tax Preparers provide free tax preparation for seniors and low income families & individuals.

**Community Impact:** Expenses - \$413 - United Way of Mahaska County is expanding its reach into the community by helping form coalitions/groups of interested parties to address needs in the community. The areas of impact that we focused on in 2015 included transportation, healthy living and childhood hunger.

**Literacy Program:** Expenses - \$0 - United Way of Mahaska County has a unique program for members of our community. In our lobby we house numerous used books and magazines that are free to the public. We have a variety of options to choose from for all ages. All materials are donated by local residents and United Way incurs no cost in providing this resource to the community.
