THE AVERAGE DAILY CENSUS WAS 134 WHICH ALLOWED THE ORGANIZATION TO PROVIDE 48,910 DAYS OF CARE. THE AVERAGE LENGTH OF STAY FOR HOSPICE PATIENTS WAS 57.3 DAYS. CEDAR VALLEY HOSPICE PROVIDES GRIEF SUPPORT SERVICES TO ANYONE STRUGGLING WITH THE DEATH OF A LOVED ONE, SERVING 4,290 GRIEF CLIENTS IN 2015.
