SHELTER HOUSE PROVIDES EMERGENCY SHELTER (UP TO 45 DAYS) FOR MEN, WOMEN, AND CHILDREN, THE DISABLED AND ELDERLY, AND TRANSITIONAL HOUSING (UP TO TWO YEARS) FOR MILITARY VETERANS. SERVICES INCLUDE BATHING AND LAUNDRY FACILITIES, A MAILING ADDRESS, A PLACE TO RECEIVE PHONE CALLS & MESSAGES AND BREAKFAST AND DINNER (OFFERED DAILY). IN THE LAST YEAR OVER 800 MEN, WOMEN AND CHILDREN WERE SHELTERED. SHELTER HOUSE FOOD SERVICE IS NOT ONLY FOCUSED ON MEETING THE NEEDS OF OUR RESIDENTS BUT ALSO CONTRACTS OUT MEAL PRODUCTION FOR AREA NON-PROFITS. OUR KITCHEN PRODUCED OVER 55,000 MEALS FOR THOSE EXPERIENCING HOMELESSNESS IN JOHNSON COUNTY AND OTHER AT-RISK INDIVIDUALS. THE DROP-IN CENTER PROVIDES A RANGE OF SERVICES INCLUDING BATHING AND LAUNDRY FACILITIES, ACCESS TO PHONES, ACCESS TO PROFESSIONAL STAFF, TOILETRY AND CLOTHING DONATIONS, AND BUS TICKETS. SERVICES ARE AVAILABLE DAILY ON A WALK-IN BASIS FOR ANYONE IN NEED. A NURSE MANAGED HEALTH CLINIC, OUTREACH FROM THE VA, PRO BONO LEGAL SERVICES, COUNSELING SERVICES, AND PAYEE SERVICES ARE AVAILABLE WEEKLY. OVER 590 PEOPLE WERE SERVED THROUGH THE DROP-IN CENTER IN 2015.

THE SUPPORTED TRAINING AND ACCESS TO RESOURCES (STAR) PROGRAM WE PLACE HUNDREDS OF PEOPLE BACK IN THE FORCE AND INTO THEIR OWN APARTMENTS EACH YEAR. PARTICIPANTS ENGAGING IN THESE SERVICES RECEIVE CASE MANAGEMENT, LIFE SKILLS TRAINING, ASSISTANCE WITH EMPLOYMENT SEARCHES AND EMPLOYMENT PLACEMENT, AND ACCESS TO SUPPORTS NEEDED TO RETAIN EMPLOYMENT INCLUDING BUS TICKETS, CLOTHING AND EQUIPMENT NEEDED FOR WORK, CHILDCARE ASSISTANCE, TRAINING AND SUPPORT IN ACCESSING MEDICAL CARE AND OTHER HEALTH BENEFITS FOR WHICH THEY QUALIFY. IN 2015, OVER 575 PEOPLE WERE ASSISTED. 51% EXITED TO PERMANENT HOUSING, 81% EXITED WITH AT LEAST ONE SOURCE OF INCOME, AND 56% WERE EMPLOYED UPON THEIR DEPARTURE FROM THE SHELTER.

IN 2015 SHELTER HOUSE PROVIDED PERMANENT SUPPORTIVE HOUSING AND MORE THAN 35 ADULTS WITH SERIOUS PERSISTENT MENTAL ILLNESS (DIAGNOSES OF SCHIZOPHRENIA, BIPOLAR DISORDER, AND MAJOR DEPRESSION) WITH PREFERENCE GIVEN TO MILITARY VETERANS. THE FAIRWEATHER LODGE IS A COOPERATIVE LIVING MODEL; EMPLOYMENT IS REQUIRED. TO THIS END, SHELTER HOUSE LAUNCHED FRESH STARTS, A COMMERCIAL JANITORIAL SERVICE THROUGH WHICH WE PROVIDE JOB TRAINING AND EMPLOYMENT FOR LODGE MEMBERS. THE FAIRWEATHER LODGE IS A RECOVERY PROGRAM FOR PEOPLE WITH SERIOUS PERSISTENT MENTAL ILLNESS EXPERIENCING HOMELESSNESS WHO ARE SEEKING COMMUNITY, PEER SUPPORT, LONG TERM STABLE HOUSING, SUPPORTED EMPLOYMENT, AND MENTAL HEALTH STABILITY.
