COMPENSATION LEVELS OF OTHER STAFF WERE ORIGINALLY SET BASED ON LEVELS FOR SIMILAR POSITIONS IN THE COMMUNITY. IN 2013, THE PRESIDENT REVIEWED A NEW COMPENSATION STUDY TO REASSESS THE COMPENSATION LEVELS OF OTHER STAFF. THE PRESIDENT ALSO USES INDEPENDENT NON-PROFIT SURVEYS THAT HAVE BEEN PERFORMED IN THE REGION. THE PRESIDENT IS COMMITTED TO ENSURING ONGOING INFORMAL AND REGULAR FORMAL PERFORMANCE REVIEWS. EACH YEAR THE EMPLOYEES ARE ASKED TO COMPLETE A SELF-ASSESSMENT COMPARING ACTUAL PERFORMANCE AGAINST PRE-SET GOALS. THE SELF-ASSESSMENTS ARE USED DURING THE ANNUAL PERFORMANCE REVIEWS. SALARY INCREASES MAY BE CONSIDERED AFTER THE ANNUAL REVIEWS.
