The PCC is obligated to reimburse the USOC for these services, which have been calculated at the USOC's cost. Legal and accounting services are billed to the PCC at a fixed monthly rate. Information technology, communications and human resources services are reimbursed to the USOC based on an hourly rate for services performed. The Executive Director's services are billed based on actual costs incurred by the USOC for salaries, benefits and payroll taxes.
