The Welcome House program provides adult male alcoholics and addicts, 21 years of age and older, with a safe place, the support, and the direction necessary to build a foundation in recovery In the 45 years since its humble beginning, Welcome House has served 1,200,000 meals, held more than 40,000 12 step meetings, and helped over 15,000 men seeking sobriety and a place to turn their lives around Our methods to monitor program and resident performance and success are both empirical and statistical Program and resident success is monitored through resident observation and feedback, as well as the capture, documentation, and evaluation of key performance indicators Examples of key performance indicators, captured monthly, include but are not limited to the following admissions, discharges, length of stay, relapses, AWOLs, meeting attendance, sponsorship, employment and rent payment A resident is considered to have successfully completed the program if the following criteria have been met at discharge the resident is clean and sober, the resident is employed, the resident has met all program requirements, the resident has been in the program for a minimum of 120 days, the resident is current on meeting attendance, the resident is current on counseling sessions, the resident is current on rent payments In most cases, residents have also prepared for discharge be securing alternative housing as well as built relationships and a foundation within the recovery community
