Our camping network includes 21 camps specializing in serving the diverse needs of our campers. The Camps For Kids Network is generating life-affirming results for our campers as well as new skills, sound decisions-making, and values and friendships that last a lifetime. In 2015, Camps For Kids provided support to 21 summer camp programs for more than 3,600 underprivileged and special needs youth.
