The former Endowment Trust received a bequest during the year ended December 31, 2011, which included artwork and other items. At December 31, 2014, the measurable value of this bequest is \$1,479,880. A portion of this gift is displayed in Peabody Hall, in an exhibition titled "Inspired by Nature," a collection of original paintings by wildlife artist and conservationist Robert Bateman. This artwork is directly related to the Zoo's mission to educate the public about wildlife and conservation. These assets were transferred to the Association as a result of the dissolution of the Endowment Trust.

The endowed funds are held for the purpose of advancing the Saint Louis Zoo and furthering its conservation and education mission. Specifically,

the endowed funds currently provide funding for the WildCare Institute, education outreach, professional positions, employee recognition and zoological operations. The endowed funds were transferred to the Association at 12/31/2011 as a result of the dissolution of the Endowment Trust.

After a full time position becomes available, the opening is graded at a certain level and then matched within a specific salary range. Determining the rate of pay for each candidate involves consideration of cost-of-living data and that candidate's experience level, education and current salary. This job is weighed against comparable positions at similar institutions and the local market. A discussion is held with the director of human resources, the hiring manager and the division vice president. Finally, after all of these steps are completed, an offer is tendered.
