Supportive Housing - Provided transitional housing and related supportive services to 60 women in recovery from drug and alcohol addiction. Services included housing services to the women and to 109 of their children. 62% of clients who moved out in 2015 graduated successfully by maintaining sobriety for at least one year and transitioning successfully to independent housing.

Family Therapy - full-time licensed therapist trained in trauma informed therapy provided over 650 hours of on-site individual, family and group therapy to 47 adults, 35 children and 21 families. In addition, therapist provided over 500 hours of therapeutic support services.

Family Self-Sufficiency programs - 50 mentors provided twice a month mentoring program to 25 moms including sharing a meal. Programming focused on solving personal and family issues to help build long-term economic self-sufficiency and employment outcomes.
