THE VISION IS ASPIRATIONAL, YET ALSO ACHIEVABLE, ALLOWING THE REGION TO LEVERAGE OPPORTUNITIES AT THE NEXUS OF HUMAN AND ANIMAL HEALTH AND REDUCE HEALTHCARE DISPARITIES. THESE NEXUS OPPORTUNITIES WILL BE DIFFERENT FOR EVERY ONE AND WILL LIKELY RANGE FROM USING NATURALLY OCCURRING CANCER IN DOGS FOR ACCELERATING HUMAN DISCOVERIES TO DEVELOPING HEALTH IT AND BIOINFORMATICS APPROACHES FOR ANIMAL HEALTH. THE SYMPOSIUM WAS DESIGNED FOR PHYSICIANS, VETERINARIANS AND SCIENTISTS INTERESTED IN RESEARCH AND CLINICAL TOPICS OF ZOO NOTIC AND VECTOR-BORNE DISEASES, INCLUDING NOVEL APPROACHES FOR DISEASE CONTROL. THE AGENDA FOCUSED ON FOUR OVERLAPPING AREAS: ZOO NOTIC DISEASES, VECTOR-BORNE DISEASES, FOREIGN ANIMAL DISEASES, VACCINES AND NOVEL APPROACHES FOR DISEASE CONTROL. WAYNE CARTER, PROVIDED AN OVERVIEW OF "PATH TO 2025," A 10-YEAR VISION AND PLAN THAT POSITIONS THE REGION AT THE NEXUS OF HUMAN AND ANIMAL HEALTH AND PROVIDES RECOMMENDED STEPS TO KEEP THE REGION GLOBALLY COMPETITIVE. THEY HIGHLIGHTED THE STRENGTHS IDENTIFIED IN THE REPORT AND WHERE OPPORTUNITIES EXIST FOR THE REGION TO DISTINGUISH ITSELF. THE COMPLETE REPORT IS AVAILABLE ONLINE AT HTTP://WWW.KCLIFESCIENCES.ORG/REPORTS/PATH-TO-2025/. THE 2015 "SCIENCE TO ART" SILENT AUCTION FEATURING THE INTRINSIC ART FOUND IN BIOMEDICAL RESEARCH WAS AGAIN A HUGE SUCCESS. SCIENTISTS FROM ACROSS THE REGION SUBMITTED IMAGES THAT WERE PROFESSIONALLY CURATED, PRINTED, AND FRAMED. ADDITIONALLY, A VIDEO HIGHLIGHTING THIS YEAR'S SCIENTISTS AND THEIR INCREDIBLE PASSION FOR STEAM (STEM AND ART) WAS SHOWN DURING THE DINNER AND CAN BE VIEWED AT HTTP://WWW.KCLIFESCIENCES.ORG/EVENTS/ANNUAL-DINNER/#SCIENCE-TO-ART-VIDE. THE 2015 AUCTION YIELDED PROCEEDS OF \$5,383. BECAUSE OF THE IMPORTANCE IN SUPPORTING EDUCATION AS IDENTIFIED IN "PATH TO 2025," KCALSI MATCHED THESE PROCEEDS TO MAKE OVER \$10,000 AVAILABLE FOR "STEAM" EDUCATION, SPECIFICALLY BIOGENIUS, PREP-KC, SCIENCE PIONEERS, AND ARTIST, INC. 6 EXPONENTIAL KC FOLLOWING THE ANNUAL DINNER, KCALSI WITH THE SUPPORT OF THE KAUFFMAN FOUNDATION HELD A FULL DAY OF EXPONENTIAL LEARNING FOR COMMUNITY LEADERS CALLED EXPONENTIAL KC. THE PURPOSE OF EXPONENTIAL KC WAS TO EXPOSE COMMUNITY LEADERS AND ENTREPRENEURS TO THE OPPORTUNITIES THAT LIE WITHIN EXPONENTIAL TECHNOLOGIES. SALIMS MESSAGE PRESENTED AT THE ANNUAL DINNER WAS ALIGNED WITH THE OCTOBER 1 EXPONENTIAL KC EVENT AND PROVIDED AN INSPIRING ARGUMENT FOR EXPONENTIAL THINKING AND OPPORTUNITIES. THE EXPONENTIAL KC EVENT BROKE MANY BARRIERS BUT MORE THAN ANYTHING WAS AN ENDEAVOR TO KEEP KANSAS CITY COMPETITIVE IN THE GLOBAL ECONOMY IN LIEU OF A PRINTED PROGRAM. KCALSI INTRODUCED A MOB.

THIS INAUGURAL CONFERENCE ATTRACTED OVER 170 ATTENDEES, AND WILL BECOME AN ANNUAL SYMPOSIUM WITH THE NEXT CONFERENCE PLANNED FOR THE SPRING OF 2017. A TOTAL OF 33 PROFESSIONALS, INCLUDING KEYNOTE SPEAKERS DR. JESSICA TENENBAUM OF THE DUKE TRANSLATIONAL MEDICINE INSTITUTE AND DR. CHRISTOPHER A. LONGHURST OF STANFORD CHILDRENS HEALTH, PRESENTED THEIR EXPERTISE IN SEVEN THEMED DISCUSSION PANELS. THE PANELS CONSISTED OF FOUR BRIEF SPEAKER PRESENTATIONS FOLLOWED BY A DISCUSSION OF THE TOPICS PRESENTED. ONCE AGAIN, KCALSI EMPLOYED A MOBILE APPLICATION TO PROFILE THE CONFERENCE AGENDA, SPEAKER BIOGRAPHIES AND ABSTRACTS, AND ATTENDEE CONTACT INFORMATION. THE BIOSCIENCE AND TECHNOLOGY BUSINESS CENTER (BTBC) INCUBATOR HOSTED A RECEPTION AND DINNER WITH FEATURED SPEAKERS, JILLIES NAGEL, PH.D., INTERIM PRESIDENT OF KU INNOVATION & COLLABORATION AND G.R. UNDERWOOD, BTBC'S PRESIDENT AND COO. DAY TWO WAS FILLED WITH RESEARCH HIGHLIGHTS IN PROTEIN STRUCTURE, VACCINE DEVELOPMENT, BIOENGINEERING, AND INFECTIOUS DISEASES AND CANCER. THE TWO-DAY EVENT CLOSED WITH TOURS OF THE HAWORTH HALL'S MICROSCOPY AND ANALYTICAL IMAGING, AND GENOMICS DEPARTMENTS. 9 HEARTLAND CIVIC COLLABORATIVE ASSET MAPPING CIVIC LEADERS FROM DES MOINES, KANSAS CITY, OMAHA, AND ST. ADDITIONALLY, 389 UNIVERSITY RESEARCH INSTITUTES AND CENTERS WERE IDENTIFIED IN THE FOUR-STATE REGION FOR POTENTIAL COLLABORATION OPPORTUNITIES. EMPLOYMENT IN LIFE SCIENCES COMPANIES WAS ESTIMATED AT 82,800. THE DATA COMPILED THROUGH THE ASSET MAPPING PROJECT ALLOWS THE REGION TO TARGET COMPANY RECRUITMENT AND ENHANCE COMPANY NETWORKS WITHIN SUB-SECTORS. INFORM STRATEGY DEVELOPMENT GUIDING ECONOMIC DEVELOPMENT ACTIVITIES. ENHANCE ACADEMIC-INDUSTRY PARTNERSHIPS FOR EFFICIENT COMMERCIALIZATION OF NEW INNOVATIONS. IVAN BROWN, CEO OF BROWNMED, KCALSI MANAGED AND FACILITATED THE MEDICAL DEVICE NETWORK - KANSAS CITY. IN APRIL, 2015, THE NETWORK'S WEBSITE - WWW.MDNKC.COM WAS LAUNCHED TO PROVIDE AN INTERACTIVE MAP REFLECTING THE VARIOUS MEDICAL DEVICE COMPANIES AND A SEARCHABLE COMPANY DIRECTORY.
