Provided food, after-school programs, tutoring, special classes, community service training, to an average of 60-70 children Monday-Friday. Conducted day camps in summer. Provided services to the elderly. Held a Warm Christmas event, distributing backpacks with blankets, hygiene items, brush, comb, gloves, hat, school supplies, and a toy, for 100 children.

4b (Code) (Expenses \$ 130,634 including grants of \$ 20,756) (Revenue \$)

First Baptist Church, Corinto, Nicaragua. Continued expansion of Hope Centers (we now have three) providing food, after-school programs, tutoring, special classes, community service training, to an average of 90-100 children on a daily basis. Built a multipurpose building to help reach children and adults on a barrier island with similar programs and we provide maintenance on the building. Held a "cool" Christmas event, distributing climate-appropriate supplies, hygiene items, and a toy to 100 children. Conducted day camps in the summer. Total number of meals provided in 2015 were 15,000.

Warm Christmas Project. Distributed backpacks to 1,284 children at 6 locations in public housing areas and churches.
