IN 2015, THERE WERE 30,200 PATIENT DAYS AND 1,760 NEWBORN DAYS. IN ADDITION, THE HOSPITAL PROVIDED 87,400 OUTPATIENT AND EMERGENCY SERVICES AS A VOLUNTARY, NONPROFIT, COMPREHENSIVE ORGANIZATION. SAINT LUKE'S NORTH HOSPITAL IS COMMITTED TO SERVING ALL WHO SEEK OUR SERVICES REGARDLESS OF THEIR SOCIOECONOMIC STATUS.
