The Health Center provided board education for the community members in the Lead program, which teaches them to be excellent board members. This helps them do well for the facility and also for other boards that they serve on. First Care Health Center works with the local development corporation to provide affordable housing. The Health Center hosts meetings for the Walsh County Ministerium. FCHC staff has assisted community members in obtaining health insurance or Medicaid. Disaster drills are periodically done, in cooperation with local law enforcement, ambulance crews, and others, in order to respond appropriately in the event of a real disaster. Anyone not responding or not making a payment after 180 days is turned over to a collection agency.

First Care Health Center sponsors drives to collect school supplies for the area schools and food donations to the local food pantry. FCHC participates in mentoring medical, pharmacy, nursing, and health careers students. First Care Health Center also provides nail care at a nominal fee by licensed staff. This service serves as a first step in checking for issues in diabetic patients. The fee does not cover the cost of space, salaries, or supplies but is done more as a service to patients. First Care Health Center provides many other services that benefit the community for which there is little or no reimbursement. The following list provides examples of some of the services and programs offered: *Tours of the hospital to children *Provide rooms for overnight stay for families of patients *Training to area vocational high school students *Provide preceptorships for nurses *Provide educational pamphlets and brochures to the community *Provide free medical advice from registered nurses via telephone *Provide meals to parents of pediatric patients *Personnel run errands for patients *Provide supplies and movies for activities and crafts for swing-bed patients *Pay for local travel for swing-bed patients
