THE SOCIETY MAINTAINS A HISTORICAL SITE "BONANZAVILLE, USA" LOCATED IN WEST FARGO, NORTH DAKOTA. THE SITE INCLUDES A GROUP OF MUSEUM BUILDINGS, ALONG WITH A GROUP OF HISTORICAL STRUCTURES WHICH HAVE BEEN RELOCATED TO THE SITE. ACTIVITIES INCLUDE THE DISCOVERY, COLLECTION AND PRESERVATION OF DATA, OBJECTS OR MEMORABILIA OF HISTORICAL VALUE AND THE DISSEMINATION OF INFORMATION CONCERNING THE HISTORY OF CASS COUNTY AND THE STATE OF NORTH DAKOTA. IN 2015, BONANZAVILLE HAD 10,500 VISITORS, 3,600 OF WHICH WERE SCHOOL CHILDREN FROM THE REGION AS PART OF LOCAL HISTORY CURRICULUM. BONANZAVILLE HAD SEVERAL EVENTS DURING THE YEAR INCLUDING PIONEER DAYS, 4TH OF JULY CELEBRATION, AND CHRISTMAS ON THE PRAIRIE.
