The SCAN Foundation's mission is to advance a coordinated and easily navigated system of high-quality services for older adults that preserve dignity and independence. During 2015, the Foundation disbursed \$6,951,274 in cash grants to other organizations to help achieve their mission.

The SCAN Foundation started its grant-making activities in 2008. In January 2009, the Foundation Board of Directors formally adopted a 5-year strategic plan, and grant-making through the 2013 fiscal year occurred in accordance with this plan. In December 2013, the Board approved an updated five-year Strategic Framework for 2014-2018 that is guiding the Foundations current work. The 2014-2018 Strategic Framework builds on the initial three funding priorities of the Foundation: (1) Raising public awareness and engagement, (2) Advancing realistic policy options around financing and delivery system reform, and (3) Bringing promising programs to scale. Within these funding priorities, the new Strategic Framework outlined three specific Thematic Goals, focused to serve specific populations: (1) Medicare-Medicaid Integration bridging care and financing for low-income older adults, (2) Person-Centered Care putting decisions in the hands of people and families, (3) Long-Term Care Financing enabling working families to pay for long-term care needs. As in the past, the SCAN Foundation's grant-making is primarily for the benefit of Californians. However, since care for California seniors is to a large extent financed by the federal government (through Medicare and Medicaid), the policy work of the Foundation also has a federal focus. The following highlighted projects shaped progress in the Foundations Thematic Goals in 2015.

**Thematic Goal 1. Medicare-Medicaid Integration** The Foundation has been a pioneer in building the business acumen of non-profit organizations, in order to prepare them to contract with the health care sector, which is required to achieve true medical care and long-term services and supports integration. It is an important objective for the Foundation under this goal to enable health plans to implement effective care coordination models through appropriate networks. In 2015, the Foundation launched its second Linkage Lab Academy, which is training six California vanguard community organizations to be able to contractually partner with the health care sector. One of these six organizations was sponsored by a Northern California Foundation, and the entire Linkage Lab Academy model was replicated by another foundation in Colorado. The Foundation continued its support of the Administration for Community Living in bringing together thought partners on a national level and to engage in similar efforts throughout the country, and regularly convened foundations throughout the country via monthly teleconferences to explore national efforts in this space. Also in 2015, the Foundation commissioned four online video trainings covering key topics of the Linkage Lab Academy, which are on its website. The Foundation continued its support of the Community of Constituents, made up of 18 Regional Aging and Disability Service Coalitions, and the Sacramento-based California Collaborative. These organizations meet weekly by phone and twice a year at a conference, including the Foundations Summit on Long-Term Services and Supports Transformation. The goal of this effort is to develop a shared vision and to find a unified voice in transforming and shaping the service delivery system for older adults and people with disability in the state. Finally, the Foundation invested significant resources for the development of new quality measures, that measure not only good medical care, but also the Medicaid funded long-term services and supports, including comprehensive care coordination. **Thematic Goal 2. Person-Centered Care** 2015 was marked by laying important groundwork in this area, in order to be able to achieve large scaling of person-centered models of care throughout California. This groundwork consisted of three bodies of work: (1) the development of a national consensus definition of person-centered care and its key elements (conducted by the American Geriatrics Society), (2) an environmental scan of the California health care system, to understand where person-centered models of care are already being implemented and where the greatest opportunities for future scaling lie (conducted by Avalere Health), and (3) the development of the business case for person-centered models of care and a sophisticated return on investment tool, both of which were developed by Dr. Victor Tabbush, Professor Emeritus of the University of California, Los Angeles, Anderson School of Business, and will be released in the first half of 2016. This goal focuses on the Medicare only population, for older adults with chronic illness and functional limitations.

**Thematic Goal 3. Long-Term Care Financing** Building on renewed interest and activity towards bipartisan policy development to solve the long-term care financing problem, the Foundation funded four interrelated projects to launch the creation, testing, and initial vetting of viable long-term care financing policy solutions. The Foundation engaged the Bipartisan Policy Center to create highly visible, pragmatic, and achievable bipartisan recommendations that are being developed by respected senior political leaders from both parties. In order to provide a common basis for political discussions so that any of these proposed policy options can receive serious consideration, it is necessary to develop a realistic set of cost estimates and economic impact analyses of these options. The Foundation engaged the Urban Institute and Millman to model the related costs and savings to Medicaid of the key policy options. This effort was supported by the convening of policy leaders to provide technical advice about the specifications of each policy option for modeling so that the proposals are balanced and practical. The stakeholders included another key constituency with great interest in solving the long-term care financing problem, namely national employer and insurer groups. The results of the important modeling work were released during a Health Affairs briefing in Washington, D.C. in November, and included wide coverage of the written materials in Health Affairs and other policy publications. In addition to these important goals and efforts, the Foundation spends a very significant amount of time and resources to engage consumers and the informed public, through a broad swath of communication efforts. These include projects with National Public Radio, Kaiser Health News, PBS Next Avenue, to name a few. The Foundation also provided financial and intellectual support to the White House Conference on Aging, which took place in July 2015.
