WENS operates Summer Nature Camps which served 676 kids during 2015 from ages 4 to 17. Camps included training in naturalist studies, outdoor survival skills and self-sufficiency skills. All Camps took place outdoors at local parks and open spaces. 63 families in need received scholarship assistance for camp in the form of discounted tuition.

4b (Code) (Expenses \$ 52,435 including grants of \$) (Revenue \$ 58,352)
WENS operates After-School Programs that served 221 kids in grades 1-5. The programs were operated at 8 different local schools in cooperation with the school administration. 41 families in need received scholarship assistance in the form of discounted tuition.

4c (Code) (Expenses \$ 6,336 including grants of \$) (Revenue \$ 9,597)
WENS operates Winter and Spring Break camps which served 126 students in grades K-5. These programs all took place at Oak Hill School. 10 families received scholarship assistance in the form of discounted tuition.
