The undersigned, being a natural person of the age of eighteen (18) years or more, acting as the incorporator of the Corporation under Chapter 181 of the Wisconsin Statutes, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I**NAME**

The name of the Corporation is The Birch-Sturm Memorial Fund, Inc. ("Corporation").

ARTICLE II**PURPOSES**

The Corporation is organized and shall be operated exclusively for charitable, scientific and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of any future United States internal revenue law (hereinafter the "Internal Revenue Code"). Only to the extent consistent with the foregoing, the specific purpose of the Corporation shall be to provide financial support from time to time to further certain of the exempt purposes of the Wisconsin Lions Foundation, Inc. ("Foundation"), including, without limitation, financial support for the Wisconsin Lions Camp, children's vision screening, diabetes, hearing, eyeglass recycling and other projects and programs of the Foundation, as determined by the Board of Directors of the Corporation; provided, however, that the Foundation remains an organization exempt from federal income taxation under Section 501(a) of the Internal Revenue Code as an organization described in Section 501(c)(3) of the Internal Revenue Code.

ARTICLE III**LIMITATIONS ON ACTIVITIES**

A. Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income taxation under Section 501(a) of the Internal Revenue Code as an organization described in Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

B. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

C. In the event the Corporation is classified as a private foundation under the Internal Revenue Code, the Corporation shall:

(1) Distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code;

(2) Not Engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code;

(3) Not retain any excess business holdings as defined in Section 4943(c) of the Internal Revenue Code;

(4) Not make any investment in a manner as to subject the Corporation to tax under Section 4944 of the Internal Revenue Code; and

(5) Not make any taxable expenditure as defined in Section 4945(d) of the Internal Revenue Code.

ARTICLE IV **MEMBERS**

The Corporation shall not have members.

ARTICLE V **BOARD OF DIRECTORS**

The Corporation shall be governed by a Board of Directors. The authority and responsibilities of the Board, as well as the number of Directors and the manner in which the Directors are to be elected, shall be set forth in the Corporation's Bylaws.

ARTICLE VI **DISSOLUTION**

Upon the dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the Corporation's liabilities, dispose of all of the Corporation's assets exclusively for the purposes set forth in Article II of these Articles of Incorporation, to such organization or organizations organized and operated exclusively for charitable, scientific and/or educational purposes as shall at the time qualify as an organization or organizations described in Section 501(c)(3) of the Internal Revenue Code, and in such manner as the Board of Directors shall determine.
